

Case Study: Regulating Carthorse Operators

Background

- Carting Industry has its roots in District Six and was used to 'smous' (hawk) fish, fruit, vegetables, bottles and bones (Carthorse Protection Association)
- Informal scrap metal collection, 'smous' (hawking) fruit and vegetables, garden waste removal

Who are 'Carties'?

- Male
- Ages: 16 older
- Owns a horse, donkey/ hired horse or donkey for a day – R150 p/day
- Bonteheuwel, Uitsig, Netreg, Mitchells Plain, Kalksteen fontein etc (Cape Flats) (not in city centre)
- Work in Pinelands, Athlone,
 Mowbray, Rondebosch, Maitland etc. (closer to the city centre)
- Driver (E53 permit)
- Works scrap, hawk with fruit and vegetables, 'garden jobs'
- Works 3-7 days a week





How do they carry out their work?



- Travel to different areas
- Door to door collection - calling out for scrap
- Garden Jobs
- Mobile scrap buy-in
- Bulk at home
- Go to scrap yards (big or small ones)

What is regulated?

- Informal scrap metal collection is regulated in two key spaces
- a) 'On the cart': what they do on the cart, how the horse is treated, how the cartie interacts with the public
- a) 'Op die Pad': 'On the streets': When, where and how carties are able to work in the city.

How is it regulated?: 'On the Cart'

- 2010: Registered cart horse:
 'Number plate is the permit'
- Gone through the E53 process
- Driver
- Operator
- Carthorse Commandments (tien gebooie)
- 'ZERO TOLERANCE Policy'directed at owners to choose the right drivers





The Ten Commandments

Cart Horse Protection Association Commandments

- 1) Will not work their horse too fast.
- 2) Will not work their horse too hard.
- 3) Will not **overload.**
- 4) Will not beat or whip their horse.
- 5) Will not be on the road **before** sunrise and after sunset.
- 6) Will not work too far.
- Will not work without an ID plate or temporary permit.
- 8) Will not work without an Operators Permit.
- 9) Will not be rude to members of the public.
- 10) Will not use their "lot" to steal or dump.



'Op die Pad': 'On the Street'

Police

- Regulating the collection of scrap
- Regulating entry in certain areas

'Nee hulle sien jou elke dag in die straat...hulle trek jou elke dag af en dan kyk hulle op die wa...verstaan mevrou...hulle skud sommer vir jou ook uit kyk of jy nie iets op jou het nie...' (SC2)

Neighbourhood Watches and Community Improvement Districts

- Regulating entry
- Littering and dumping

'...Jy haal net die scrap van die wa af...of jy sit die kos van die perd neer dan is dit sommer n fine...' (SC3)

Public: 'Eyes and Ears'

- Report when you witness any abuse of horses
- Reporting dumping, illegal activities and road traffic violations.

'The Bright yellow number plate at the back of the cart has an ID number for the horse...Please quote this number!' (CHPC Letter)
